## Federal Office

---

**Dartmouth-Hitchcock has been at the front line of the COVID-19 response in New Hampshire and the region. The pandemic has greatly impacted our fiscal health, care delivery, and the communities we serve.**

- What steps will you take to assist with the fiscal recovery of hospitals in New Hampshire?
- How will you ensure a robust supply chain of medical supplies?
- What waivers and flexibilities that have been put in place by CMS during the pandemic would you support making permanent?
- What steps would you take to address the needs of our communities during the pandemic?

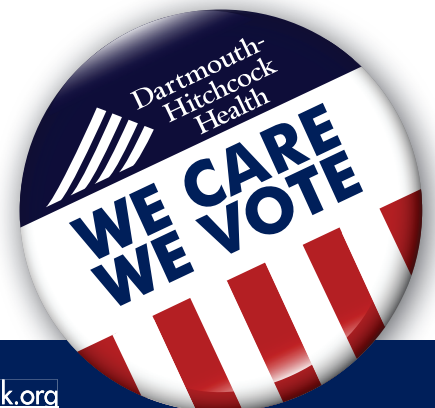
**Many of Dartmouth-Hitchcock's patients rely on Medicare as their source of health insurance. In their September 2020 budget outlook, the Congressional Budget Office predicts that the Medicare Hospital Insurance Trust Fund will be unable to fulfill its commitments by 2024, sooner than previously predicted.**

- If you are elected to the federal office you are seeking, what will you do to ensure that Medicare is available and that all seniors will be able to access the medical care they need?

# Questions for Candidates

## New Hampshire

---

**COVID-19 has strained all healthcare systems, including systems for mental health care. New Hampshire was once known for having one of the best mental health systems in the nation. Now, however, it has slipped to a point where many people have little or no access to quality care.**

**Concurrently, people struggling with substance use disorders have also been at risk of falling into the shadows cast by COVID-19.**

- What would you do differently to provide necessary services for people experiencing mental health and/or substance use disorders?
- What aspects of these systems would you focus on resourcing and/or changing?

**In 2018, the New Hampshire Legislature passed Medicaid Expansion with the condition that NH implement work requirements for Medicaid beneficiaries. In 2019, New Hampshire's work requirement for Medicaid beneficiaries was struck down by a federal court.**

- Do you support work requirements for Medicaid beneficiaries?
