

**Official Rules**  
**Blood Donor Program of the Dartmouth-Hitchcock Medical Center "A New Lease on Life"  
Raffle**

- 1. THE RAFFLE AND HOW TO ENTER.** The Blood Donor Program of the Dartmouth-Hitchcock Medical Center, along with the Dartmouth-Hitchcock Clinic, for itself and on behalf of Mary Hitchcock Memorial Hospital, operating jointly as "Dartmouth-Hitchcock", a New Hampshire not-for-profit corporation (the "Sponsor") is acting as Sponsor of the "A New Lease on Life" for the Prize. To enter the Raffle, a Contestant must fill out and submit an entry form with the Sponsor's blood bank. Each Contestant may submit only one Raffle ticket entry at a time. No entries may be generated by robotic or other automated means. The Raffle begins at 12:01 AM June 2, 2018 and ends at 11:59 PM on December 7, 2018. By participating in the Raffle, Contestants accept and agree to these Official Rules and agree that all decisions made by Sponsor regarding any aspect of the Raffle, including the selection of the winner, shall be final and binding in all respects. Raffle entry forms will be available at the Sponsor's Blood Donor Center located at on Level 2, Faulkner Building, Dartmouth Hitchcock Medical Center, 1 Medical Center Dr., Lebanon, NH 03756.
- 2. NO PURCHASE OR TRANSACTION NECESSARY TO ENTER OR WIN.** The Raffle is open to all eligible Contestants (see conditions of Eligibility, below). Contestants are not required to be customers or patients of Sponsor, to make any purchase or payment, or to make a donation to the Sponsor's blood bank in order to enter the Raffle. Making a purchase, donation, or being a customer of Sponsor does not increase the chance of winning. Odds of winning are determined by the number of entries received.
- 3. THE PRIZE.** GHNH, Inc. d/b/a Gerrish Honda ("Gerrish") award the Winner (chosen by Sponsor pursuant to Section 5 herein) a one-year/15,000 mile automobile lease for a 2018 Honda Civic LX Hatchback (the "Prize") offered exclusively by Gerrish. The approximate retail value of the Prize is \$5,000.00. Winner must take delivery of the vehicle at Gerrish Honda, 369 Miracle Mile, Lebanon, NH and will be responsible for taxes, insurance and compliance with all lease terms related to the Prize. Winner must qualify for the Prize according to Gerrish's leasing standards and the award of such prize is subject to final approval by American Honda Finance Corporation. In the event that the Winner does not qualify for the Prize, the Winner may either attempt to qualify for the Prize with a co-signer or accept a non-transferable credit with a value of \$5,000 that may be used towards the purchase of i) a new, 2018 Honda Civic LX Hatchback; ii) any used Honda in Gerrish's inventory; or iii) parts or services from Gerrish (the "Service Credit"). Should the Winner choose the Service Credit option, the Winner must use the Service Credit within 365 days of receipt of the Service Credit. Winner will be required to provide proof of insurance that is adequate to cover the total retail value of the Prize. The Prize is not transferrable except in the sole discretion of Gerrish.
- 4. ELIGIBILITY.** The Raffle is open to legal residents of any of the 50 United States or the District of Columbia who are at least 18 years old, have a valid mailing address, and provide Sponsor with a valid tax identification number. The following individuals and their immediate family and household members are not eligible to participate: Employees, Senior executives, officers, directors, and agents of Dartmouth Hitchcock Clinic, its advertising and promotional agencies, and any entity involved in conducting the Raffle or determining the eligibility of any Contestant or the validity of any entry. "Immediate family members" includes parents, children, siblings, and spouse. "Household members" includes persons living at the same address, whether or not related. "Employees" shall mean the employees of the following units of Sponsor: All employees of the Blood Donor Program of Dartmouth-Hitchcock Medical Center and any and all employees with supervisory responsibility or oversight of the Blood Donor Program of Dartmouth-Hitchcock Medical Center. The eligibility of any potential winner will be verified before an actual winner is declared. The potential winner will be required to sign and return an Affidavit of Eligibility, Liability Release, and Publicity Release within ten (10) days of notification attempt. If Sponsor is unable to reach the potential winner or if the potential winner is ineligible, declines to accept the Prize, or does not cooperate with the verification or documentation process, the Prize will be forfeited and Sponsor may select an alternate winner in the sole exercise of its discretion. The determination of the Sponsor is final.
- 5. DRAWING, NOTIFICATION & IDENTIFICATION OF WINNER.** The winner will be selected by Sponsor in a random drawing of eligible entries on December 8, 2018 (the "Winner"). Winner need not be present to win. Winner will be notified by phone or email following the drawing date and must appear at a time, date and location specified by Sponsor to claim and receive the Prize. Winner will be asked to provide proof of age and identity.
- 6. ADVERTISING AND PROMOTION.** By entering the Raffle, each Contestant consents to the use of his or her name, photograph, and likeness, without compensation or notice, for advertising and promotional purposes

relating to the Raffle, Sponsor and Gerrish. Furthermore, each Contestant agrees, if he or she wins the Raffle: (1) to make himself or herself available to pose for and make such photographs, recordings, and videotapes as Sponsor and its designees, or Gerrish and its designees, shall reasonably request at no additional expense, and (2) that Contestant shall not be entitled to review or approve any such photographs, recordings, videotapes or other uses of Contestant's name, likeness, or voice.

- 7. RELEASE OF SPONSOR AND RELATED PARTIES.** By entering the Raffle, Contestant agrees to release, discharge and hold harmless Sponsor and its affiliates, subsidiaries, agents, and contractors, and their respective officers, directors, employees, and agents, from any injury, loss or damages of any kind resulting from the Raffle, the Prize, any publicity relating to Sponsor or the Raffle, and the acceptance, use, misuse or possession of any prize received in this Raffle. Without limiting the foregoing, by participating in the Raffle, participants agree that Sponsor, its agents, directors and employees have no liability whatsoever for any physical injuries of any kind which result from use of the Prize, or by participation in the Raffle. In addition, Sponsor is not responsible for error, omission, interruption, deletion, defect, delay in operation or transmission, communications line, technical network, electronic or computer failure, theft or destruction or unauthorized access to, or alteration of entries, incomplete, garbled, delayed or stolen entries, or for lost, late, damaged, postage due or misdirected mail.
- 8. PLAYING FAIR.** Anyone attempting to damage or undermine the legitimate operation of this Raffle may be in violation of criminal and civil laws. Sponsor, its promotional partners, and Gerrish each reserve the right to seek damages and other remedies from any such person(s) to the fullest extent permitted by law and to disqualify from the Raffle any person(s) that it suspects of making such an attempt. Sponsor and its promotional partners reserve the right to suspend or cancel the Raffle on account of fraud, technical failures, or any other cause that corrupts the administration, security, or proper play of the Raffle. Any determination made by Sponsor and its partners under this paragraph shall be final.
- 9. PRIVACY.** Each Contestant acknowledges that Sponsor's Privacy Policy is hereby incorporated by reference and applies to the submission of entries pursuant to these Official Rules. Sponsor's Privacy Policy is available upon request. By participating in the Raffle, each Contestant hereby agrees to Sponsor's collection and usage of the Contestant's personal information and acknowledges that Contestant has read and accepts Sponsor's Privacy Policy.
- 10. APPLICABLE LAW AND TAX INFORMATION.** The Raffle is subject to all federal, state, and local laws and is void where prohibited by law. The winner will be solely responsible for all costs associated with title, registration, insurance, licensing, delivery and other applicable fees associated with their respective prize, as well as for all local, state and federal taxes, including, but not limited to without limitation, all luxury, special and income taxes that may be applicable. The Prize must be accepted as awarded and is not transferable. No substitutions are allowed other than at the sole discretion of Sponsor.
